# LAND GOVERNANCE IN TRANSITION How to support transformations that work for people and nature?

4-5 July 2019 – Utrecht, the Netherlands



The LANDac Annual International Conference offers a podium for researchers, practitioners and private sector representatives interested in land governance for equitable and sustainable development. The 2019 Conference looks at land governance through the lens of transformations: what are the long-term dynamics around land, water and food production? How is land governance itself transformed, as it seeks to respond to changing circumstances? And how is learning and knowledge building about these dynamics developing, what are promising concepts and tools? Particular questions relate to the different aspects of land governance, such as gender, food security, land tenure security, investments, conflict prevention and peace-building. In a fast-paced world of short-term projects and funding, how can we learn from past and current transitions, build sustainable partnerships and networks, and allow for seeds of innovation to bear fruit?

#### LAND GOVERNANCE IN TRANSITION

The LANDac Annual International Conference 2019 will look back at the decade since the land grab "hype" began, analysing the transformation processes that have taken place in those locations where investments have been made, and revisiting our understanding of the implications of these investment flows for food security, livelihoods and sustainable development. Land governance has transformed to meet diverse challenges, across dimensions of generations and gender, rural and urban, local and global. But what are the long-term dynamics around land, water and food? How can we improve development impact via early engagement with investments? What has been the role of advocacy and mediation efforts? Can we secure a sustainable future for both people and nature?

To answer these questions, we also need to look ahead. We need to assess new challenges in the field, such as land governance in the context of climate change and increasing, often conflicting pressures on land and natural resources. Widely diverging issues like climate displacement, resilience, migration, ecosystem restoration and green grabbing, access to food and water, and informal settlements are increasingly framed in terms of security. But such securitisation is often used to legitimise restricting land access for the poor. How do we pave the way for transformations in land governance that minimise negative inter- and externalities and that balance between stakeholder groups? How do we put our knowledge and experience to work and support transformations that benefit both people and nature?

LANDac – the Netherlands Academy on Land Governance for Equitable and Sustainable Development – brings together researchers, policy makers, development practitioners and business professionals in the field of land governance and development. With a focus on new pressures and competing claims on land and natural resources, the LANDac network conducts research, disseminates information, and organises courses and training, while strengthening linkages between actors who may not usually meet. Our guiding question is how to optimize the link between land governance, sustainable development, and poverty alleviation.

LANDac is a partnership led by, and based at, the International Development Studies (IDS) Group of Utrecht University. Other partners include: the African Studies Centre Leiden, Agriterra, the Faculty of Geo-Information Science and Earth Observation (ITC) of the University of Twente, the Royal Tropical Institute (KIT), the Ministry of Foreign Affairs, Land Portal, Oxfam Novib, Royal Haskoning DHV, VNG International and Wageningen University.
